

**EAST HOPEWELL TOWNSHIP
RESOLUTION # 17- 2025
A RESOLUTION REIMPOSING AND SETTING THE TAX
RATES FOR EAST HOPEWELL TOWNSHIP
FOR THE YEAR 2026**

BE IT RESOLVED, by the Board of Supervisors of the Township of East Hopewell, and it is hereby resolved, in lawful session assembled, as follows:

SECTION 1. REALTY TRANSFER TAX LEVY

A tax upon the transfer of title to real estate located within East Hopewell Township at the rate of one-half of one per cent (0.5%) of the fair market value of the property being transferred. The Pennsylvania Department of Revenue is further reappointed as the Township's Agent to determine on the Township's behalf any additional taxes, together with interest and costs, and to charge the Township the collection fee authorized by the Local Tax Enabling Act.

SECTION 2. EARNED INCOME TAX LEVY

A tax of one-half of one percent (0.5%) upon the earned income of residents of East Hopewell Township and upon the net proceeds derived from the operation of any business or other activities by residents of East Hopewell Township and a tax of one-half of one percent (0.5%) upon the income earned by non-residents of East Hopewell Township within East Hopewell Township and a tax of one-half of one percent (0.5%) on the net proceeds derived from any business or other activities conducted in East Hopewell Township by non-residents, with credits being granted to non-residents in the amount of tax paid to the local government of such person's residence on account of income earned in East Hopewell Township. This tax is re-imposed pursuant to Ordinance No. 3-2011, amending and continuing the prior ordinances establishing this tax, while conforming to the requirements of Act 32 of 2008, 53 P.S. s.6924.501. et. seq.

SECTION 3. REAL ESTATE TAX LEVY.

A real estate tax for general Township purposes at the rate of 1.0 mills, or ten cents (\$0.10) per each One Hundred Dollars (\$100.00) of assessed valuation (ten cents [\$0.10] per one hundred dollars (\$100.00) of assessed valuation, for a multiplication factor of (.00100) is hereby assessed upon real property within the Township made taxable for general township purposes pursuant to the provisions in Section 3205 (1) of the Pennsylvania Second Class Township Code, Act of May 1, 1933 (P.L. 103, No. 69) reenacted and amended November 9, 1995 (P.L. 350, No. 60) as amended.


SECTION 4. DISCOUNT. All taxpayers subject to the payment of the tax imposed by Section 3., above, shall be entitled to a discount of two percent (2%) from the amount of such tax upon making payment of the whole amount thereof within two (2) months after the date of the notice.


SECTION 5. PENALTY. All taxpayers who shall fail to make payment of the whole amount of the tax imposed by Section 3., above, for four (4) months after the date of the tax notice, shall be charged a penalty of ten percent (10%) of the whole amount thereof.


SECTION 6. EFFECTIVE DATE. This Resolution and the taxes and tax rates herein shall be effective January 1, 2026.
