(3) The Municipality reserves the right to make an award on the basis of quotations received for any item or on the basis of the aggregate total for all like items on which quotations are received.

PROPOSAL AND CONTRACT INSTRUCTIONS

1. The proposal must be typewritten or printed.
2. If more than one proposal on any project is submitted by any individual, firm or partnership, corporation or association under the same or different names, only one lowest proposal will be considered.
3. Bid bonds may be waived by municipality by crossing it out on Proposal Form 963.
4. Part A of page 1 is to be completed by the municipality. Part B of page 1 is to be completed by the supplier. Schedule of Prices - under equipment section the municipality must complete description, delivery date, delivery site, and check appropriate block (s) for outright purchase or rental with purchase option. Under material section all like materials must be listed together and space provided for a total of all like materials. EXAMPLE: All classes of concrete, all sizes of concrete pipe, all sizes corrugated metal pipe, all asphalt materials, etc. Columns 1, 2, 3, 4, and 5 (be sure to include delivery date) must be filled in by the municipality to insure equitable bidding. All of Columns 6, A, 7, B, 8, and C must be filled in by the supplier, unless otherwise indicated. (Unit Price delivered as directed does not apply to bituminous pavements. Use form MS-944.) If more space is needed, add note at the bottom of the page: " Continued on Attachment 1 - A" and add additional sheet designated as Attachment 1-A, 1-B, etc. Repeat note for each additional sheet required. Municipality may eliminate one or two pairs of Columns 6 through C, if no bids are desired under one or two of the options.
5. Performance bonds are provided by only the successful bidder. Bond must be in 50% of contract amount.
6. Where Materials for a Wearing Surface Treatment are part of the contract Average Daily Traffic (ADT) Count must be included in the description.
7. Contractor awarded the bid shall receive an approved copy of the contract.
8. Form MS-963 is not to be used for purchasing bituminous or other pavements in place. IF ALTERNATE BIDS MUST BE SECURED, BOTH MS-963 AND MS-944 MUST BE USED.
9. This form is PRIMARILY for use when work is performed by Local Forces.
10. An ESCALATOR CLAUSE is optional; however, it must be included in the proposal prepared by the Municipality. An escalator clause MAY NOT be inserted by the contractor.
11. Freight On Board (FOB) asphalt is subject to the requirements of Publication 408, Section 110.04(a) Price Adjustment of Bituminous Materials.

ATTACHMENT A

ESCALATOR CLAUSE

The contractor/supplier shall have the right to increase the contract unit price of the item(s) specified below the amount equal to the contractor/supplier's increase in cost of such item(s) occurring subsequent to the date of the bid opening (hereinafter referred to as "base date"). Any increase (or decrease) in the contractor/supplier's cost of such item(s) after the base date shall be verified by proper documents furnished to the municipality, including proof of price to the contractor/supplier from the contractor/supplier's source of supply.

Should the contractor/supplier's allocation of any item(s) be materially reduced by the contractor/supplier's source of supply, the contractor/supplier may reduce proportionately the quantity of such item(s) to be delivered in accordance with this contract.

The municipality may withdraw or reduce the quantity of any item or terminate or reduce the scope in accordance with this contract:

- (a) If the unit cost of any item covered by these escalator provisions is increased more than 10% above the base price, or
- (b) If, because of an increase in the unit cost of more items covered by these escalator provisions, the total estimated cost of the contract is increased more than 10% above the base price.

SPECIFICATIONS FOR E-3 AND E-3M EMULSION

10,000 gallons, more or less, E-3 Emulsion and 30,000 gallons, more or less, E-3M Emulsion to be supplied to the Township and to be delivered in lots of 300 gallons or more in trucks equipped with spraynose for skin patching.

All material must meet Penn DOT Specifications and shall be paid for on a 60 degree F temperature.

Letter of availability and analysis must accompany each bid. A bid bond of 10% must be included with each bid. The successful bidder must supply a Performance Bond of 100% of Bid.

Escalator Clause applies.

PennDOT Form 963 must be used and are available from the Township Secretary, Laura Vasold, 8916 Hickory Road, Felton, PA 17322-8102. Phone 717-993-6529.

Bids must be in the hands of the Township Secretary on or Tuesday, June 2, 2026 at 12:00 pm. at which time they will be publicly read. Bids will be awarded at the regular meeting on Wednesday, June 3, 2026. Sealed envelopes must be plainly marked "BIDS FOR ROAD OIL".

Suppliers must agree to deliver oil within 72 hours of order from Township Roadmaster, Road Foreman or Secretary.

Truck drivers making deliveries or doing work in/for East Hopewell Township must have a current Commercial Drivers License, as required by law.

The Board reserves the right to accept or reject any bids in the best interest of the Township.
